

**LICENSE AGREEMENT FOR THE USE OF
GAIT-IST Dataset**

The two parties agree as follows:

1. LICENSOR developed certain valuable intellectual property, known as the "GAIT-IST dataset" consisting of images of 10 subjects, captured by a smartphone camera with 1280x720 pixel resolution, at the Multimedia Signal Processing Group of Instituto de Telecomunicações – Instituto Superior Técnico, Lisbon, Portugal.
2. LICENSOR grants a license to LICENSEE for the use of the GAIT-IST dataset in the scope of the non-profit research and academic use.
3. This license shall not be construed as to transfer any right over the GAIT-IST dataset.
4. LICENSEE shall have no rights over the GAIT-IST dataset or any portion thereof and shall not use the GAIT-IST dataset except as expressly set forth in this Agreement.
5. Subject to the terms and conditions of this Agreement, LICENSOR hereby grants to LICENSEE for non-profitable research and academic use only, for a period of 2 years starting at the effective date above mentioned, renewable upon the discretion of LICENSOR, a royalty-free, nonexclusive, nontransferable, license subject to the following conditions:

5.1 The GAIT-IST dataset may only be used by the LICENSEE and, in a need-to-know basis, of those direct research colleagues who belong to the same research institution as LICENSEE and have acceded to the terms of this license.

5.2 The GAIT-IST dataset will not be copied nor distributed to any third party.

5.3 The GAIT-IST dataset may only be used for research and standardization purposes and will not be used nor included in commercial applications in any form.

5.4 Any work made public, whatever the form, based directly or indirectly on any part of the GAIT-IST dataset will include the reference to the publication mentioned in 7 below.

5.5 This license will expire two years after the EFFECTIVE DATE, in case the license agreement is not renewed by both parties (LICENSOR and LICENSEE), the LICENSEE shall permanently destroy all copies of the GAIT-IST dataset.

6. Compliance with data protection laws applicable to LICENSEE is LICENSEE's sole responsibility.
