## LICENSE AGREEMENT FOR THE USE OF

The two parties agree as follows:

- 1. LICENSOR developed certain valuable intellectual property, known as the "Lenslet Light Field Ear Database (LLFEDB)" consisting of 67 subjects, with images captured by a Lytro ILLUM light field camera. Two separate sessions were performed for each subject with a temporal separation between 1 and 6 months. The database includes 8 image shots per person in each of the two sessions. This dataset is derived from the IST-EURECOM Light Field Face Database (LFFD), containing only the ear region from a relevant subset of images.
- 2. LICENSOR grants a license to LICENSEE for the use of the LLFEDB Database in the scope of the non-profit research and academic use.
- 3. This license shall not be construed as to transfer any right over the LLFEDB Database.
- 4. LICENSEE shall have no rights over the LLFEDB Database or any portion thereof and shall not use the LLFEDB Database except as expressly set forth in this Agreement.
- 5. Subject to the terms and conditions of this Agreement, LICENSOR hereby grants to LICENSEE for non-profitable research and academic use only, for a period of 2 years starting at the effective date above mentioned, renewable upon the discretion of LICENSOR, a royalty-free, nonexclusive, nontransferable, license subject to the following conditions:

- 5.1 The LLFEDB Database may only be used by the LICENSEE and, in a need-to-know basis, of those direct research colleagues who belong to the same research institution as LICENSEE and have acceded to the terms of this license.
- 5.2 The LLFEDB Database will not be copied nor distributed to any third party.
- 5.3 The LLFEDB Database may only be used for research and standardization purposes and will not be used nor included in commercial applications in any form.
- 5.4 Any work made public, whatever the form, based directly or indirectly on any part of the LLFEDB Database will include the reference to the publications mentioned in 7 below.
- 5.5 With the exception of subjects number 1, 2, 3, 4 and 5, no other image obtained from the LLFEDB Database may be included as a figure in any form of publication/display unless if expressly authorized in written by LICENSOR.

  When using images of subjects number 1, 2, 3, 4 and/or 5 of the database for any type.

When using images of subjects number 1, 2, 3, 4 and/or 5 of the database for any type of publication/display the explicit reference to the image source must be included.

- 5.6 This license will expire two years after the EFFECTIVE DATE, in case the license agreement is not renewed by both parties (LICENSOR and LICENSEE), the LICENSEE shall permanently destroy all copies of the LLFEDB Database.
- 6. Compliance with data protection laws applicable to LICENSEE is LICENSEE's sole responsibility.
